Membership Dues and Drive Fee are due no later than May 1st to participate in the drive.

BUDDY SEATS MUST BE APPROVED BY THE SAFETY DIRECTOR BY APRIL 15. Safety Director is Fred Petsch, 402-416-5561, fredpetsch715@gmail.com

FORMS WILL BE RETURNED if not fill out completely and with all supporting documents!

All meals have not been finalized to date. We may include more dinners: however, plan for breakfast on your own unless we can find an entity to provide it. Meals are sometimes free, free will donation, or a fixed price. Cost of meals will be on the final schedule you receive prior to the drive and will be payable at the location of the meals.

Use the check list below to ensure that you complete all requirements:

TRACTOR DRIVERS – drive fee is \$45 for 1 day or \$70 for 2 or more days.

Include copy of the tractor drivers Driver's License

Include copy of proof of **1 Million dollar Liability Insurance** covering the tractor you will be driving. Please note if you are driving a tractor belonging to someone else.

If the tractor you are driving belongs to someone else, include a copy of proof of 1 Million dollar Liability Insurance covering yourself.

BUDDY RIDERS or OTHER NON-TRACTOR DRIVERS – drive fee is \$45 for 1 or more days.

Buddy Riders can never drive a tractor, and Buddy Seats must be approved by April 15th.

SUPPORT VEHICLE DRIVERS – drive fee is \$45 for 1 or more days.

If you are registering the inclusion of a support vehicle, include a copy of proof of 1 Million dollar Liability Insurance covering the support vehicle (may be a blanket policy covering yourself, tractor, and support vehicle)

ALL PARTICIPANTS (you are a participant even if you are only riding along in a support vehicle, and the drive fee is \$45 for 1 or more days)

Ensure that ALL participants have signed the RULES FOR THE RIDE form.

Include a signed copy of the Waiver of Liability, Assumption of Risk, and Indemnity Agreement.

Add up the dollar amount of any merchandise ordered, OCW donation, any meals listed, Membership dues, and TRAN drive fee, and include a check for that amount.

This form does NOT need to be turned in.

RULES FOR THE RIDE

Name (print): _____

1. Driver must show proof of a **valid driver's license**, obey all traffic laws and follow designated route.
2. Driver must show proof of **\$1,000,000 liability insurance on tractor being driven on TRAN.**
3. **Mandatory SMV sign and Rearview Mirror on tractor.**
4. Drive tractor that can maintain a speed of no less than 12 mph.
5. Will not carry extra riders except for on approved buddy seats. (buddy seat requirements below)
6. Will not pull campers or any trailer that would block my view. No riders in or on trailers.
7. Do not pass other tractors or engage in any horseplay or racing.
8. Brakes must be in good repair and operate fully.
9. Do not have duals on the tractor
10. Do not have bicycle companions.
12. You are responsible for your own mechanics and repairs.
13. Must abide by the decisions of the ride management team in event of inclement weather or safety concerns.
14. Must be responsible for any personal and/or property damage caused by the tractor I'm driving or me.
15. Optional but **highly recommended**: Fire extinguishers.

Buddy Seat Requirements: Buddy Seats must be registered no later than April 15, 2023.

1. A minimum of 4 photos of the seat mounted and bolted to the tractor must be sent to NAFA for approval. Even if the tractor may have a seat for a rider from factory, it will still need to be approved by NAFA. May be mailed or emailed.
2. All Buddy Rider seats must be secured to the tractor beside the driver if possible. No Buddy Rider will be directly behind the driver unless there is a safety bumper separate from the seat frame. No Buddy Rider will be ahead of the driver. Absolutely no Buddy Rider seats mounted directly to the rear straight drawbar only.
3. Seat must not be rusted out or welded up.
4. Tractor must have fenders to protect the Buddy Rider from the tractor tires.
5. There can be absolutely no interference to the driver's ability to drive the tractor on the route safely. This includes tractor steering, clutch, brakes, and vision of the driver. The driver must have full control of the tractor at all times. At no time will the Buddy Rider be allowed to have control of the tractor.
6. All seats must have a secure and safe back support for the rider
7. A grab handle must be secured to the tractor for the Buddy Rider's safety during the drive.
8. Seat belt use is at the sole discretion of the Buddy Rider.
9. Club officials have the right to deny any Buddy Rider or driver during this event.
10. Buddy Rider must register and pay membership and drive fees by May 1st, 2023. By signing the participant form, the Buddy Rider agrees to abide by the above rules. Failure to comply with these rules will disqualify the individual and the buddy rider from participating in the event.

If the Safety Director and/or a NAFA Board Member deem a tractor and/or operator unsafe while on the drive, they will be asked to discontinue. I understand that breaking these rules may result in action being taken against me by the ride management team, to include, being dismissed from the ride and the denial of future participation. NAFA reserves the right to refuse any registration.

I HAVE READ and understand the Waiver of Liability, Assumption of Risk, and Indemnity Agreement, and have voluntarily signed and enclosed an individual copy of it.

I HAVE READ and understand the above information and THE RULES FOR THE RIDE, and I pledge and certify my compliance by my signature. It is agreed that this complete Safety Pledge, Waiver Release, and Consent is binding on my heirs and assigns.

Waiver of Liability, Assumption of Risk, and Indemnity Agreement

WAIVER OF LIABILITY -- In consideration of being permitted to join the Nebraska Antique Farming Association (the "Association") and participate in any way in the Association's activities (hereinafter called "The Activities"), including, but not limited to, Tractor Relay Across Nebraska, I, for myself and on behalf of my heirs, next of kin, representatives or assigns, do hereby release, waive, discharge, and covenant not to sue the Association, its Board of Directors, Executive Officers, staff, representatives, affiliates, volunteers, and agents from liability from any and all claims including the negligence of the Association, its Directors, Executive Officers, staff, volunteers, representatives, affiliates, and agents, resulting in personal physical or psychological injury, accidents, illnesses, paralysis, death, and property loss arising from, but not limited to, participating in the Association's activities.

ASSUMPTION OF RISK -- Participating in The Activities carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injury. Specific risks vary from one activity to another, and can range from minor injuries (scratches, bruises, sprains), major injuries (loss of sight, eye injuries, joint or back injuries, heart attacks, concussions, catastrophic injuries (paralysis and death), and can include, but are not limited to physical and psychological injury, pain, suffering, illness, disfigurement, temporary or permanent disability, economic or emotional loss, and death. I have read the previous paragraphs and I know, understand, and appreciate these and other risks are inherent in the Activities. I hereby assert that my participation is voluntary and that I knowingly assume both known and unknown all such risks.

INDEMNIFICATION -- I agree to indemnify and hold the Association, its Directors, Executive Officers, staff, volunteers, agents, and representatives harmless from all claims, actions, suits, procedures, costs, expenses, damages, and liabilities, including any attorney's fees brought as a result of my participation in the Activities and to reimburse them for any such expenses incurred.

SEVERABILITY -- The undersigned further expressly agrees -- that the foregoing waiver, assumption of risks, and indemnification are intended to be as broad and inclusive as is permitted by the law of the State of Nebraska and that if any portion thereof is held invalid or unenforceable, it is agreed that the remaining terms shall notwithstanding, continue in full legal force and effect.

IMAGE RELEASE -- I irrevocably consent to and authorize the use by the Nebraska Antique Farming Association (the "Association") of any and all photographs, videos, voice recordings, or other media taken of me including derivative works thereof (collectively, "images") and any reproduction of them in any form in any media whether now known of hereafter created, throughout the world in perpetuity. I consent to the use of my name and likeness, or an assigned fictitious name in connection with the exhibition, distribution, merchandising, advertising, exploiting, and/or publicizing of the Association. These uses in, but are not limited to, videos, publications, websites, news releases, emails, and any other promotional and educational materials in any medium. I acknowledge that I will not receive any compensation for the use of such videos, images, likenesses, etc. I hereby release and discharge the Association, its Directors, Executive Officers, staff, representatives, affiliates, volunteers, and agents from liability, from any and all claims, suits, or demands in connection to images or likenesses of me and the reproduction thereof as aforesaid. This includes claims for invasion of privacy, right of publicity, misappropriation or misuse of image, and defamation. I agree that the Association will be the exclusive owner of all rights, including, but not limited to, in copyrights, in and to the images, in whole or in part, throughout the universe, in perpetuity, in any medium now known or hereafter developed, and to license others to so use them in any manner the Association may determine in its sole discretion, without any obligation to me. This agreement is made and being entered into under the laws of the State of Nebraska and shall be governed and interpreted in accordance with the laws of the state. This agreement embodies the entire agreement of the parties (subject and photographer). No modifications of this agreement shall be of any effect unless it is made in writing and signed by all the parties to the agreement. I hereby waive any right that I may have to inspect and/or approve the use of the Images or any reproductions thereof, by the Association.

ACKNOWLEDGEMENT OF UNDERSTANDING -- I have read this Waiver of Liability, Assumption of Risk, and Indemnity Agreement, fully understand its terms, and understand that I am giving up substantial rights, including my right to sue. I acknowledge that I am signing the agreement freely and voluntarily and intend my signature to be a complete and unconditional release of all liability to the extent allowed by the law.

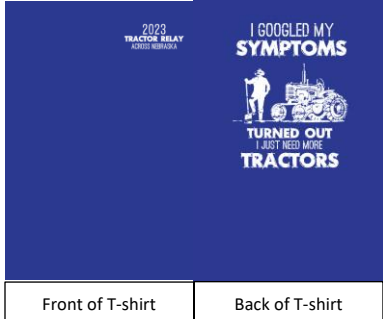
